Health & Safety

As we come to the end of the year we are able to celebrate the award of RoSPA Gold status and another year with zero RIDDOR reportable accidents. Such achievements have only been made possible through promoting the right culture throughout our workforce by providing bespoke training and employing initiatives such as 'Don't Walk By' which encourage continual improvement.

Our 'Don't Walk By' behavioural safety initiative launched in early 2015 has played a key role in raising the bar across health & safety, allowing us to create an inclusive working environment where the opinions of our employees are recognised and valued. Following several observations in relation to people/ plant interface we have revised toolbox talks and introduced the 'Thumbs Up' initiative which increases plant operator awareness.

We continue to invest heavily in training and are currently putting all levels of site supervision including Foreman through the IOSH Managing Safely Certificate which combines face to face tutorials with distance learning.





Project In Focus - Peterhead Northern Breakwater

Following a severe storm on the east coast of Scotland the Northern Breakwater, at the Port of Peterhead was badly damaged resulting in a section of wave wall and the breakwater structure breaking away and being washed into the sea. Southbay were awarded a contract to repair a 30m section of the breakwater by removing damaged concrete blocks and replacing with new 30 tonne pre-cast blocks tied in with insitu concrete. The new pre-cast blocks were constructed on site by our own direct labour. Works also involved constructing a new 87m section RC wave wall. The project which is being undertaken in a very exposed environment has been the subject of severe sea conditions requiring a proactive approach to all aspects of construction. This has included maximising resource output through weekend working to make up for lost time due to weather conditions.

Corporate Social Responsibility

In addition to the mandatory training we provide our employees we also support professional development within the company. Our Senior Quantity Surveyor Shaun Heelbeck is currently working towards becoming a member of the Royal Institute of Chartered Surveyors. We have also recently employed an Apprentice Joiner in Dan Hunter who is currently in his first year of training, and recently secured his NVQ Level 1 in Health and Safety Awareness.

Workload 2016

Across 2016 we have successfully delivered and secured a number of challenging contracts many of which have involved working within some of the UK's most heavily used ports including the Port of Tilbury and the Port of Peterhead. Through maintaining a flexible and proactive approach to on-site delivery a number of these contracts have been programmed around bespoke client requirements including multiple vessel movements and have involved working within exposed environments subject to gale force winds and high tidal swells.

West & East Quay Gabion Revetments (PD Teesport)	£100k	The construction of stone filled gabion baskets in front of two separate sections of revetment.
Oban Pier Refurbishment (Northern Lighthouse Board)	£65k	Concrete infill works to existing voids located below the pier harstanding slab.
